The recommendations will feed into the ongoing bi-regional policy dialogue which seeks to enhance scientific and technological cooperation on the decision maker level. The recommendations will:

- define and update science, technology and innovation (STI) priorities in the area: future EU-Pacific cooperation, recommendations to policy makers, and <u>identification of</u> <u>innovation niches</u>;
- define joint "projects" such as calls for research, exchange of knowledge between the Pacific and EU and vice-versa, programming work (potential synergies, use of existing programmes); and







- Marine toxins (covering taxonomy and diversity of toxin-causing species, bioaccumulation
 of the toxins in the foodweb, and ecological impacts on marine organisms and
 ecosystems);
- The effects of climate change and environmental disturbances on fish and seafood poisoning (covering climatic and anthropogenic drivers of seafood poisoning);
- Health (covering epidemiology, diagnosis and treatment (including traditional practices));
 and
- Societal, cultural and economic aspects (covering nutrition/dietary aspects and changes, food security, changes to traditional behaviours,communication/prevention and economic impacts).
